Between

And

..... hereby called **Beneficiary**

There occurred the following Contract :

ART.1 THE OBJECT OF THE CONTRACT

The Provider will provide a travel package, according to the description below.

Art. 2 CONFIRMATION TERM

The booking will be confirmed upon signing of this contract. Once this contract is signed, full refund is no longer possible, according to the conditions hereunder.

Art. 3 CONTRACT TERMS

- 4.1. All tariffs are expressed in EUR.
- 4.2. These tariffs will not be disclosed to any third party.
- 4.3. All tariffs include VAT and other local taxes.

Art. 4 DETAILS OF THE PACKAGE

Note 1 – Extra-services

Other extra-services will be agreed upon in written form and signed by both parties.

Note 2 – Availability of services

The Beneficiary agrees to use the services booked within the agreed time frame, without delays that might alter other customers. Delays while using hotel rooms, guides, vehicles booked by the Provider will only be possible with written consent of the Provider.

Note 3 – Modifications of the schedule

If there occur modifications after the signing of the contract, the Provider has the right to deny them if they are not transmitted in due time or they might alter the development of this and / or packages provided to other customers.

Art. 5 PAYMENT TERMS

- 6.1 The package will need to be guaranteed by the payment in advance of the total amount at least 30 days before the beginning of the services. This amount will be paid upon receipt of the Provider's invoice.
- 6.2 The final invoice including eventual changes and / or additions will be issued in EUR. It will be paid within 7 days of receipt.
- 6.3. The payment of the deposit will be done by bank transfer or credit card, as settled between the two parties. In all situations, bank charges or credit card payment charges will be covered by the Beneficiary.

6.4. The Provider has the right to refuse fulfilling its obligations if the Beneficiary does not pay the deposit according to the terms above. For any delays, the Beneficiary will pay a charge of 0.5% per day of delay.

Art. 6 CANCELTION AND MODIFICATION TERMS

In case of cancelation, the following charges will apply:

- 2 month notice: 0% of the total contract price (full refund granted)
- 5 week notice: 20% of the total contract price
- 4 week notice: 50% of the total contract price
- 20 day notice: 70% of the total contract price
- 10 day notice: 90% of the total contract price
- less than 10 day notice: 100% of the total contract price

Art. 7 OTHER CLAUSES

8.1 If the number of persons included in the package (and hence in this contract) drops under the value settled for this price, the Provider has the right to ask for a different price, set in regards to the new number.

8.2 Both parties are exonerated of responsibility in case of force majeure.

8.3 Any argument or problem between the two parties will be dealt upon with mutual understanding. If this is not possible, it will be referred to through the Chamber of Trade and Industry of Romania.

8.4 All negotiations and correspondance before the signing of the contract and which are contradictory with the statements of this contract will be nul.

8.5. The Beneficiary will reimburse the Provider any damage caused to hotel / vehicles / other equipment used by the Beneficiary and belonging to the Provider (or rented by it).

8.6. The Beneficiary will start and end the program within the set time frame. If the time frame settled upon is bypassed (for using cars / hotel rooms / guides etc.), the Provider reserves the right to intervene, anytime this is necessary.

8.7. The Provider does not assume responsibility for the loss or destruction of any items belonging to the Beneficiary that happen during stays in hotels or while traveling.
